## 595/22 Highway Matters

The following matters were reported.

Pot hole outside Langfauld, Langrigg

Street light no 6 outside Sycamore House is out

Highways had advised they had assessed the report regarding the alleged unauthorised placing of stones along the verge outside a new build property on the C2010 in Blencogo. Highways had investigated this matter and advised that the verge on which the stones are situated is unregistered with the Land Registry, therefore, they are unable to instruct the homeowner to remove the stones. However, they are to raise a works order to have the stones removed.

Dog fouling continues to be an issue

Cllr Brough reported an issue with a footpath stile at Langrigg and agreed to contact the Countryside Access Team. The Clerk agreed to circulate the link to report highway issues on line.

### 596/22 Items for Discussion:

Projects for 2023-24 – Members considered projects for the forthcoming year. Suggestions put forward included improving the lighting in the village hall car park and improvements to the cattle grid into the car park. The setting up of a warm space in the village hall was also discussed. It was noted that grants are available for village halls for the setting up of warm spaces. It was agreed to include a small article in the parish magazine asking for suggestions for projects around the parish that the council may be able to support.

Budget/Setting the Precept 2023-24 – A draft budget had been circulated with the agenda. Items of income and expenditure were considered. RESOLVED that the precept should remain at £6000.00.

Vacancies- Mr. Simon Lunken had expressed an interest in joining the parish council. Cllr Brough proposed that Mr. Lunken be co-opted onto the parish council, this was seconded by Cllr Lee. All were in favour. RESOLVED to co-opted Mr Lunken onto the parish council. Mr. Lunken will be summoned to attend the next meeting of the parish council.
