751/24 Reports from Outside Bodies

Cllr K. Thurlow provided leaflets from Cumberland Council for distribution in the Parish to remind dog owners to clean up after their dogs advising that failure to pick up after your dog is a criminal offence under Section 67 of the Anti-Social Behaviour, Crime and Policing Act 2014. Cllr Thurlow reported that Castles & Coasts Housing Association is leading a community clean up event in Harriston village, Aspatria on Tuesday 6th August, from 10am to 3pm. The community day is part of a summer multi-agency programme of 'Operation Respect' events, which aim to tackle anti-social behaviour.

Village Hall Committee – A representative from the Village Hall Committee was not in attendance. An update on the fund raising had been provided by email. The Village Hall Committee had submitted grant applications to the Cumbria Community Foundation and the Cumberland Community Panel. The application to the Community Ownership Fund had been deferred due to the General Election. Financial pledges of support had been received from the community and local businesses. The Committee are hoping to raise a minimum of £25,000 but are aiming for £30,000. 57% of the target has already been reached.
